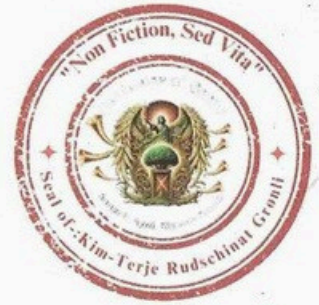

I adopt no political allegiance to any foreign state, prince, nation, king, flag, government, or principality existing outside of or within the borders of my country, except that I may move my household and establish my home in any other sovereign state;

I am living now in the country known as Norway and I declare my intention to stay in this physical location and within the borders of this sovereign state and to be counted as one of its people;

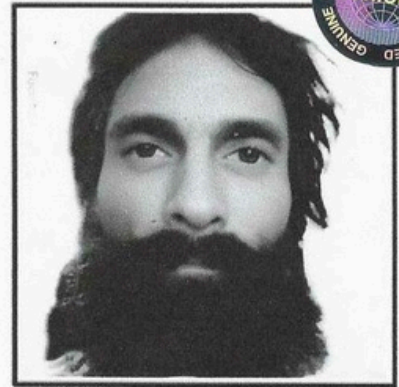

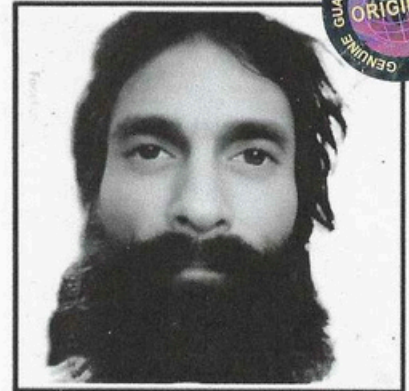
